The financial report for the quarter ending December 2023 is attached. As of December 31, 2023, the department holds cash balances in the following accounts:




This quarter resulted in a project income account balance of \$1,004,487.03

CPCC Probation Collaboration Plan Jail/Probation/Prosecutor Pre-Trial/Court Programs

Wegner

The Board will review the Collaboration Plan and progress made to date. Please find attached the updated Collaboration Plan that includes JRAC. Additionally, as presented in the Plan the Board will discuss issues relating to Probation, Prosecutor Pre-Trial Diversion, Local Jail and Court Programs.

Items for discussion include the following:

- Community Corrections/Probation Evidenced Based Practices.
 - Discuss cognitive behavioral treatment/substance abuse programming and scheduling.
- Cass and Pulaski County Jails and Treatment Protocols.
 - Discuss cognitive behavioral treatment/substance abuse programming and scheduling.
 - Community Corrections and Court Services is continuing to work with 4C Health, formally known as Four
 County Counseling Center regarding the facilitation of specified assessments and treatment opportunities
 for inmates.

Cass County Jail Programming

In collaboration with 4C Health and Court Services, the Cass County Sheriff's Department launched the Jail Therapy Program in 2021, targeted towards inmates with substance abuse disorders. Curriculum includes WRAP, Wellness Action Recovery Plan, and MORE, My On Going Recovery, relapse prevention programs aimed at assisting transition back into the community with groups for both women and men and individual counseling. Court Services deployed the ACCI Corrections eCourse Program in the Cass County Jail in 2023. Two local church groups are now facilitating faith-based recovery courses and we now allow in-person facilitators. There are currently 28 inmates in either the Wednesday Individual Counseling, WRAP or MORE Programs. 3 inmates are participating in the ACCI eCourse Program and 6 clients participating in the HSE Program. The jail currently has a 25% Program Participation Rate. In 2023, we had 51 inmates complete the WRAP/MORE programs and 30 inmates complete online courses on the tablets

This past quarter staff have continued to work on their forty (40) hour training curriculum. Both the Community Corrections and Court Services Director attended and presented at the Fall IACCAC Training Institute. In addition, Court Services Director, Hillary Hartoin, conducted two learning teams with community corrections staff on

Cognitive Skill Building and SEA 9 Data Entry. Court Services is also transitioning staff to the NIC eLearning Platform to save on costs that were incurred with the Relias Platform.

Continuous Quality Improvement Committee

The Department's Quality Assurance Committee now meets quarterly in conjunction with Pretrial and Court Services, who also holds monthly SRS Trainings that will resume after the first of the year. Case management review still is reporting metrics below the agency target of 85%-90% compliance with standards, while the agency outcome performance measures below are still within acceptable limits, as seen below, although the violation rate has increased. Analysis of client population and caseloads, show that caseload ratios are down and within acceptable limits and that current standards are attainable. Staff accountability with case management and data entry shows a need for improvement.

2023 Program Completion and Engagement Report

In 2023, the agency saw an 83% Program Completion Rate. 11% of clients did not complete programming due to revocation/return to incarceration due to a violation, with the remaining percentage of clients had their programming transferred to another post-conviction supervision/program cancelled. It is noted that Program Completion Rate is a measure of closed therapeutic programming conditions.

The Program Engagement Rate for 2023 is 78%, 16% decrease and is a measure of active and closed programming conditions. Meaning, this is the percentage of clients in the period, who have completed and/or were assigned therapeutic programming and have at least one verified attendance (engagement).

2023 Performance Measures Report



Violation Rate: the percentage of clients who received a violation; pending violations are NOT included; this is a measure of closed cases.



Safety Rate: the percentage of clients who do not commit a new offense while under supervision; this is a measure of closed cases.



Completion Rate: the percentage of clients who remain under supervision until the end of their sentence.



Drug Screen Positivity Rate: the percentage of drug screens administered that return a positive result

This past grant period Pulaski Probation and Cass County Court Services received 1006 funding for the implementation of a pre-trial release/supervision program. The following is a report on progress:

Cass County: Cass County Pretrial Policy and Stakeholder Team Members, please remember that our meetings our combined with the CPCC Advisory Board Meetings for your convenience. Below are a few brief program updates:

2023 4th QTR OVERVIEW:

Court & Pretrial Services CCCPS reports another record-breaking year in 2023. Early review shows the agency served 299 clients, a 31% increase from 2022. This was coupled with a 14% increase in evaluations and 27% increase in new intakes. We diverted \$1,598,960 in incarceration expenses, 107 years in jail bed stays. A further analysis will be highlighted in our annual report.

The Department now as a Data & Research PhD Intern from IU Bloomington, who started in January and will be validating program outcomes.

There are still several open Board positions. The Commissioners of both Cass and Pulaski counties have been approached about making the additional appointments and are awaiting our recommendations.

Info/Action Additional Funding/Courts Services & JRAC

Hartoin

Court Services was awarded the CY24 IOCS JPAR SIM Grant and was successfully able to increase funding from \$45,000 to \$155,000. Funding is designated for CPCC's therapeutic division, with additional funding awarded to expand programming offered to include evening and Saturday classes, in addition to competency evaluations for

the Courts and EBP curriculum. Court Services has been working with new provider to expand programming offered at CPCC to include both a Men's & Women's DBT Group and a Men's Trauma Group.

Court Services secured the 2024 Court Reform Grant that includes \$40,000 from the IOCS for a complete audio visual display system for one of the Courts.
