IOCS Pretrial Services Recertification

Pretrial Coaching Organizational Assessment

Ms. Hartoin to present the results of the agency's process evaluation conducted in partnership with JSP. The Pretrial Services Organizational Coaching Assessment(PS-OCA) Self-Assessment is a tool designed to help pretrial services agencies evaluate their alignment with coaching-oriented practices versus traditional referee-oriented approaches. The assessment examines multiple domains of organizational functioning and provides a framework for identifying strengths and opportunities for growth in implementing a coaching model.

Info/Action **Open Door Law IC 5-14-1.5-1 Changes** **Hartoin**

Ms. Hartoin is collaborating with County Attorney Jeff Stanton to ensure that both the Local JRAC and Community Corrections Advisory Board operations and bylaws comply with IC 5-14-1.5-1 requirements regarding Open Door Access. The necessary changes include establishing that quorums must consist of members physically present, virtual votes must be conducted by roll call, and only a limited percentage of annual meetings can be attended virtually. Ms. Hartoin will work with Mr. Stanton to outline these required changes and prepare proposed amendments to the bylaws for council approval. Discussion to take place.

Info/Action **Opioid Settlement Updates** **Hartoin**

An update will be provided regarding Cass County's Opioid Settlement Funds, including current balances of both restricted and unrestricted funds along with expense details and information about the receipt of CY24-25 funding. The discussion will also cover microgrant claim requirements. Additionally, Cass County was featured in the April 2025 EGIS Indiana Opioid Settlement Newsletter.

Info/Action **CY2026 Budgets, Needs and IDOC Grant Applications** **Hartoin/Wegner**

Directors Hartoin and Wegner will initiate discussions regarding CY2026 budgets and needs, along with information about anticipated funding cuts to the IDOC Grants. Other council members and departments are welcome to present if they wish to participate. One of our Local JRAC's key objectives is to provide the County Council with comprehensive information about the fiscal needs and services offered by our entire criminal justice system, not only before upcoming budget sessions but throughout the year. June's JRAC Meeting will include County Council Members and will focus on this topic to prepare for the upcoming budget hearings.
