CPCC Probation Collaboration Plan

Jail/Probation/Prosecutor Pre-Trial/Court Programs

The Board will review the Collaboration Plan and progress made to date. Please find attached the updated Collaboration Plan that includes JRAC. Additionally, as presented in the Plan the Board will discuss issues relating to Probation, Prosecutor Pre-Trial Diversion, Local Jail and Court Programs.

Items for discussion include the following:

- Community Corrections/Probation Evidenced Based Practices.
 - Discuss cognitive behavioral treatment/substance abuse programming and scheduling.
- Cass and Pulaski County Jails and Treatment Protocols.
 - Discuss cognitive behavioral treatment/substance abuse programming and scheduling.
 - Community Corrections and Court Services is continuing to work with 4C Health, formally known as Four
 County Counseling Center regarding the facilitation of specified assessments and treatment opportunities
 for inmates.

• Cass County Jail Programming

In collaboration with Four County and Court Services, the Cass County Sheriff's Department launched the Jail Therapy Program in 2021, targeted towards inmates with substance abuse disorders. Curriculum includes WRAP, Wellness Action Recovery Plan, and MORE, My On Going Recovery, relapse prevention programs aimed at assisting transition back into the community with groups for both women and men and individual counseling. Court Services deployed the ACCI Corrections eCourse Program in the Cass County Jail in February of this year. There are currently 20 inmates in either the Wednesday Individual Counseling, WRAP or MORE Programs. 8 inmates are participating in the ACCI eCourse Program and

we saw 5 women complete the WRAP Program in the past week. The jail currently has a 14% Program Participation Rate.

Continuous Quality Improvement Committee

The Department's Quality Assurance Committee now meets monthly in conjunction with Pretrial and Court Services, who also holds monthly SRS Trainings that resume once renovations are complete. Case management review still is reporting metrics below the agency target of 85%-90% compliance with standards, while the agency outcome performance measures below are still within acceptable limits, as seen below. Analysis of client population and caseloads, show that caseload ratios are down and within acceptable limits and that current standards are attainable. The Director continues to work with case managers and monitor caseloads to improve measurements, while Court Services works the IDOC and IOCS in creating reports to help more easily identify areas needing improvement and improve policy.

Client Satisfaction/Exit Surveys were also collected this quarter. The questionnaire is offered as a quarterly snapshot consisting of 18 questions aimed at providing the agency feedback on agency practices. Results continue to remain to be mostly positive. Clients rated their supervision in the "agree" to "strongly agree" category.

From January until May 2023 the Agency's the average amount of time Eligibilities/Recommendations are filled within 48% hours of sentencing hearings was 52%.

Review of the Agency's Sanctions, Incentives and Interventions Report shows that the current Interventions Ratio is 6.49%, approximately a 1% increase from CY22; goal is 5% increase.

From January-June of 2023 the agency saw an 84% Program Completion Rate. 10% of clients did not complete programming due to revocation/return to incarceration due to a violation, with the remaining percentage of clients had their programming transferred to another post-conviction supervision/program cancelled. It is noted that Program Completion Rate is a measure of closed therapeutic programming conditions.

The Program Engagement Rate for January-June of 2023 is 76% and is a measure of active and closed programming conditions. Meaning, this is percentage of clients in the period, who have completed and/or were assigned therapeutic programming and have at least one verified attendance (engagement).





This past grant period Pulaski Probation and Cass County Court Services received 1006 funding for the implementation of a pre-trial release/supervision program. The following is a report on progress:

Cass County: Cass County Pretrial Policy and Stakeholder Team Members, please remember that our meetings our combined with the CPCC Advisory Board Meetings for your convenience. Below are a few brief program updates:

2023 2nd QTR OVERVIEW: CCCPS saw another busy quarter, serving 85% of the 2022 total population served;194 clients. The agency also has seen a 22% increase in assessments, completing over 172 assessments at the end of the second quarter, approximately 3 times the amount of Community Corrections. This coupled with a 38% increase in new supervised intakes, illustrates a sustained surge in growth that is projected to continue with a mid-year cost savings estimate of \$634,400. Performance Metrics remain above standards as seen below.

Cass County Pretrial Services is also excited to announce that they have hired a second full-time case manager who started on July 27th.

Info/Action Hair Follicle Testing

Wegner

Ms. Hartoin to inform the Board that she has secured our contract with Cordant for Hair Follicle Testing for all local Community Supervision Agencies. Said contract covers a 9 Panel Hair Follicle Test (Amph/Methamphetamine, Benzodiazephines, Cocaine, Fentanyl, Methadone, Opiates, Oxycondone/Oxymorphone, Phencyclidine (PCP), THC) at a cost of \$71.50 per test.

Info/Action Court Services and JRAC

The Cass County Local JRAC continues to meet on a regular basis, with the last meeting held on July 26th. The Cass County JRAC has been appointed by the Cass County Commissioners to discuss, review and make recommendations regarding proposals for the Opioid Settlement Funding.

Court Services is currently expecting an award announcement on the CY24 JPAR SIM Grant. Funding requesting not only include mental health evaluations for the Cass County Courts, but over \$100,000 in funding to pay for the therapeutic side of Community Corrections.

Info/Action Programming & Work Release Audits

On May 24th our agency completed a programing audit facilitated by the Indiana Department of Corrections and the University of Cincinnati, the CPC and CPC-CSA. The purpose of the audit is to provide a baseline on where our agency is at in the implementation and practice of evidence-based practices and data entry and collection. Results are still pending. The Department's Work Release Audit has been postponed until after renovations are complete.
